ENTERPRISE ZONE TAX CREDITS

- 25% income tax credit
- Available to donors who give directly (no workplace contributions)
- Monetary gifts only (no in-kind)
- Must supply last 4 SS # digits or tax ID # with your donation
- Must specify which Enterprise Zone project you wish to support
 - The Bridge Emergency Shelter (\$200 minimum)
 - Habitat for Humanity of La Plata County (\$250 minimum)
 - Housing Solutions for the Southwest (\$100 minimum)
 - Manna Soup Kitchen (\$250 minimum)
 - The Pinon Project (\$250 minimum)
 - Volunteers of America – Durango Community Shelter (\$250 minimum)
 - Volunteers of America – Southwest Safehouse (\$250 minimum)

CHILD CARE CONTRIBUTION TAX CREDITS

- 50% income tax credit
- Available to donors who give directly (no workplace contributions)
- Monetary gifts only (no in-kind) (\$250 minimum)
- Must specify which Child Care Center you wish to support
 - Big Brothers Big Sisters of Southwest Colorado
 - Boys & Girls Club of La Plata County
 - Riverhouse Early Learning Center
 - Seeds of Learning
 - Silverton Family Learning Center
 - Treehouse Early Learning Center
 - Tri-County Headstart (Pagosa site)
